Introduction to ISO 20022



Adoption Rationale

Strategic initiative to improve payment processing efficiency and promote global interoperability

- Supports strategy 4 of the Reserve Banks' Strategies for Improving the U.S. Payment System to align the Fedwire Funds Service message format with a global standard.
- Modernizes the message format for U.S. wire transfer payments by providing enhanced and more structured data options, and new data elements.
- Not adopting ISO 20022 would make the Fedwire Funds Service fall behind the rest of the world.

World is Moving to ISO 20022

- Peer RTGS operators have already adopted or are in the process of adopting:
 - ✓ March 20, 2023 TARGET2 and EURO1 in Europe, Lynx in Canada, RITS in Australia
 - ✓ June 2023 CHAPS in the UK
 - ✓ April 2024 CHIPS® in the US
- Instant payment systems in the US and abroad use ISO 20022 messaging.
 - TIPS and RT1 in Europe
 - RTP (TCH) in the US
 - FedNow[®] live since July-2023.



Project Overview



"Go Live" on March 10, 2025

- We are on track to go live with ISO 20022 messages for the Fedwire Funds Service on March 10, 2025, in a single-day implementation.
 - All customers must be ready to send and receive ISO 20022 messages on the same day.
 - The proprietary Fedwire Application Interface Manual (FAIM) format will **sunset** and be fully replaced with the ISO 20022 format
- Engaged 1:1 with 200+ Fedwire Funds Service customers that are required to complete DIT2 certification testing by year-end:
 - Customers that have their own FedLine Direct® connection to the Fedwire Funds Service
 - Customers that import 100 or more messages per day using the FedPayments® Manager Funds application via the FedLine Advantage solution.
- Customers not in the mandatory testing group are strongly recommended to test in the DIT2 environment.

Project Scope

- The Fedwire Funds Service is a real-time gross settlement system used to initiate individual electronic funds transfers that are immediate, final, and irrevocable.
- Only the Fedwire Funds Service is in scope (Federal Reserve Financial Services is not implementing ISO 20022 messages for the Fedwire Securities Service, FedACH Service or Check Services).
- 19 ISO 20022 messages will be implemented to replace the current Fedwire Funds Service messaging flows.
- There are 25 implementation guidelines as some messages will be used for multiple purposes.



Fedwire[®] Funds Service ISO[®] 20022 Implementation Center

On June 27, 2022, the Board of Governors of the Federal Reserve System (Board) announced (Off-site) in a Federal Register notice (Off-site) that the Federal Reserve Banks will adopt the ISO 20022 message format for the Fedwire Funds Service in a single-day implementation strategy on **March 10, 2025**. With this implementation, the Federal Reserve Banks will sunset the existing proprietary Fedwire Application Interface Manual (FAIM) format and replace all FAIM messages with ISO 20022 messages.





FedLine Advantage Template Reminder & Tips

Take inventory of what you need and start creating your **new ISO 20022-formatted templates** in the **DIT2 environment**.

- Review your existing templates to determine which ISO 20022 message you need to use (see examples below):
 - o If **all parties are financial institutions**, you should be creating a **pacs.009** Financial Institution Credit Transfer message.
 - If at least one party is a non-financial institution, you should be creating a pacs.008
 Customer Credit Transfer message.
- When creating templates, have the appropriate outgoing message form open side-by-side so you can see which fields are required.
- Save and test your templates in advance of the cutover weekend (by 4:00 p.m. ET on Friday, March 7, 2025).
- We will copy them over to production, so you have them for use on the March 10, 2025, business day.

Important Note: When creating templates, you should consult your compliance and legal departments on what information you may need to include in messages to satisfy your compliance obligations.

Reminder

All FAIM-formatted templates will be deleted during the cutover weekend (i.e., March 8-9, 2025).

We will provide three ISO 20022 testing environments to help ensure that the Fedwire Funds Service community is well-prepared for the single-day ISO 20022 implementation on March 10, 2025. Given the large number of customers, service providers and software vendors we need to support for ISO 20022 testing, we developed the following testing requirements using a risk-based approach. - 1. MyStandards Readiness Portal Testing (Available since March 2023)
 - Prerequisite for DIT2 certification
- 2. Depository Testing Environment (DIT2) Testing (Available since Mid-December 2023)
 - Service providers and software vendors that have existing Fedwire Funds Service customers must complete DIT2 certification by April 30, 2024
 - Fedwire Funds Service customers must complete DIT2 certification by December 31, 2024 (we highly
 encourage you to complete your testing by October 31, 2024 to ensure you meet this deadline and
 allow the last two months for retests)
 - Opt-in peer testing online form for FedLine Direct connection owners and FedLine Advantage customers
 - FedPayments Manager Funds manual entry attestation
- B. Saturday Production "Dress Rehearsal" Testing (Q1 2025 ISO 20022 Saturday Production Testing Schedule)
 - o Must complete DIT2 certification as a prerequisite
 - Mandatory testing group to be notified directly in second half of 2024

As of January 2025

We want you to mimic your production traffic using the ISO 20022 format in the DIT2 environment every **Tuesday** and **Thursday** starting in the new year and up to the go-live weekend. Whatever messages you send in production (customer transfers, bank transfers, drawdown requests, etc.) you should do the same using the ISO 20022 format in the DIT2 environment. No forms are required, just come in and test on these days!
